Overview

As of end of December 2021, BNP Paribas Securities Services services EUR 701 billion of private capital assets across more than 2,000 structures, with local expertise across 12 locations in the private capital space. The organisation strongly believes in investing in new technologies and innovation and helps institutional clients maximise their investment opportunities globally. BNP Paribas Securities Services' goal is to be the premier asset servicing provider globally, offering comprehensive, cutting edge digital solutions to the private capital market.

Challenge

The need to deliver operational excellence and achieve economies of scale is inciting the asset servicing industry to invest in new technologies. Whilst the trend towards digitialisation to replace manual, repetitive tasks in back/middle offices is clearly visible, operational infrastructure still remains underdeveloped within private capital.

With the growing maturity of the private capital sector, BNP Paribas Securities Services had to find the right partner allowing them to tackle the main challenges they are currently facing:

Optimising processes to achieve scalability

With the strong growth of private market investors being serviced by BNP Paribas Securities Services, they needed to find an efficient way to optimise processes with clients to achieve scalability. The goal was to find a tech-enabled solution allowing for integrated workflows reducing effort and operational risks.

Enhancing decision-making

The need for best-in-class and innovative analytics is transforming private markets. BNP Paribas Securities Services had identified the requirement to deepen its analytics offering for private markets early on, striving to provide clients with cutting-edge analytical features.

Providing greater transparency more efficiently

BNP Paribas Securities Services has seen an evolving client need for transparency and 24/7 data access. Having identified the necessity for flexible look-through capabilities and reporting functionalities, a digital solution allowing for transparency whilst reducing the highly manual approach to custom investor reporting was required.

Improving investor communication

In order to simplify communication with clients and allow for more efficient communication between fund managers and their investors, BNP Paribas Securities Services needed to establish a solution, reducing the amount of emails sent and introducing a more secure way of conversing.

The partnership

In 2019 the private capital team at BNP Paribas Securities Services was tasked with identifying ways to increase the value provided to the asset servicer's clients. As the former CFO of a well-known fund manager, Karine Litou, Deputy Head of Private Capital at BNP Paribas Securities Services, was familiar with the challenge of accessing data from service providers. She knew that finding a way for clients to easily access their data could prove to be a key differentiating factor for BNP Paribas Securities Services.

Whilst considering the options of developing a digital solution directly, the team was introduced to AssetMetrix, a tech-enabled service provider originating from a German fund-of-fund-manager. BNP Paribas Securities Services particularly appreciated the in-depth understanding of the team, the ability to find solutions for the complex needs of private market participants and their agile methodology.

After intense due diligence, BNP Paribas Securities Services was convinced of the value a partnership could generate.
